She has acted as the scientific director of several International Symposiums/Workshops on Natural Dyes in India and Korea, being awarded the UNESCO Medal “Thinking and Building Peace” for her contribution to these Symposiums on Natural Dyes. She is currently preparing the forthcoming “ISEND (International Symposium and Exhibition on Natural Dyes) 2011– Europe”, in collaboration with Mrs. Anne de la Sayette, director of a research and development institute on horticulture at Rochefort-sur-Mer, France. - The rise of the woolcloth industry in medieval Europe as a model of integrated economy generating democratic and social developments : preparation of a series of books (1st volume already published, see selected bibliography).

Antiquity : Roman Egypt, Silk Road civilizations (archaeological textiles from Xinjiang, China, and Kazakhstan) ;

History and archaeology of dyeing

- Research on, and publication of medieval to XVIIIth c. dye-recipe books and technical treatises (see selected bibliography).
